PRESENTATION OF CAOPA

CAOPA was created in 2010 and brings together professional organizations from 27 African countries: Benin, Burkina Faso, Burundi, Cabo Verde, Chad, Comoros, Côte d'Ivoire, Gambia, Ghana, Guinea Bissau, Guinea, Liberia, Mauritania, Morocco, Mali, Madagascar, Mauritius, Nigeria, Senegal, Seychelles, Sierra Leone, South Africa, Tanzania, Togo, Tunisia, Uganda, and Reunion Island, as an observer member

Its main objective is to promote a pan-African dynamic for the development of sustainable small-scale fisheries for the well-being of coastal communities, and to contribute to the food security of populations. Since 2017, CAOPA has been committed to promoting the development, in a transparent, participatory and gender-sensitive manner, of national and even regional action plans to implement FAO's Voluntary Guidelines for Sustainable Smallscale Fisheries. CAOPA is a member of FiTI's Board of Directors, of the CAPE Steering Committee, and chairs the West African Platform of Non-State Actors in Fisheries, set up by the African Union. The organization has the status of observer in COFI (FAO).

INTRODUCTION

In Africa, small-scale fishing mobilizes more than ten million men and women, and feeds more than 200 million Africans. African fishing, 75% of which is small-scale, is the largest sector of the blue economy in Africa, whether in its contribution to food security, jobs created or income generated for the household. It plays an important role in the social stability of these communities.

Thousands of men and women who work in this sector rely on it for their livelihoods and to provide for their families..

The year 2022 has been declared by the United Nations as the International Year of Artisanal Fisheries and Aquaculture (IYAFA). This is an opportunity for all actors in the sector to consider the ways and means of sustainable management and governance of the sector, including the organizations that bring together the main actors active in the field, namely the professionals, whose livelihoods depend on small-scale fishing.

They make an important contribution to the livelihoods, jobs and food security of their countries.

However, the future is full of challenges for African fishing communities, especially with the impact of climate change already being felt on activities: more difficult navigation conditions at sea, coastal erosion, movement of resources further offshore, etc. But the main challenge for the future of our communities is to give young women and men the opportunity to find decent living and working conditions in smallscale fishing, to avoid, as is too often the situation today, that they fall into drug and crime, or go to illegal migration. To address these challenges, CAOPA has a compass: the Voluntary Guidelines for Sustainable Small-scale Fisheries in the Context of Food Security and Poverty Eradication and the Policy Framework and Reform Strategy for the Fisheries and Aquaculture Sector in Africa. Since 2018, CAOPA has been advocating for the development of national action plans in a transparent, participatory and gendersensitive manner for their implementation.



MAIN PROGRAMS



-Capacity building of members of African small-scale fisheries Professional Organizations;

-Support for the setting-up of good governance practices, democracy, transparency and accountability within the member organizations;

-Promotion of the role of women through policies for the development of their activities;

-Launch of a programme for the existence of a single Federation of professionals in the small-scale fisheries sector per member country.

-Promotion of the implementation of the Voluntary Guidelines for Sustainable Smallscale Fisheries;

-Promotion of the implementation of the Policy Framework and Reform Strategy for Fisheries and Aquaculture in Africa;

-Promotion of the Small-scale Fisheries Call to Action...





That is why, in its approach, CAOPA is inspired by the Sustainable Development Goals adopted by the United Nations in 2015, in particular Goal 14b, to "Ensure access to fisheries resources and markets for smallscale fisheries".

Achieving this goal must be done through concrete actions.

> In line with CAOPA's objectives, there were many and diverse activities during IYAFA 2022. In this section, we summarize the activities we carried out.

These activities focused on the following points:

- Information and awareness raising;
- Capacity building.

CAOPA organized on February 10th 2022 a webinar on "How the EU-AU partnership can support sustainable African small-scale fisheries? An African Civil Society Point of View. The objective was to exchange on how partnership between Africa and Europe can contribute to support sustainable small-scale fisheries in Africa.

2022- CAOPA published a study on the issues related to the regulation of small-scale fisheries reserved zones in Sierra Leone and Senegal respectively. The aim is to contribute to IYAFA 2022.

CAOPA organized a workshop on November 8th and 9th, 2022 in Thiès. November 2022, in Thiès, a workshop for sharing experiences on <u>alternative funding systems for small-</u> <u>scale fishing and reflection on a model</u> <u>adapted to women's activities</u>.

The general objective of this workshop was to: " strengthen the capacities of women active in small-scale fishing on alternative funding systems for their activities".



Training of canoe captains on maritime and continental safety____

The objective was to train the captains of small-scale fishing canoes of the safety issues, the need to conserve fisheries resources in a context of *increasing scarcity of resources* and a commitment to action, taking into account the celebration of the International Year of Artisanal Fisheries and Aquaculture 2022 (IYAFA).



Conclusion



IYAFA has been a very eventful year for small-scale fisheries and aquaculture.

BUT, CAOPA noticed a lack of coordination of all activities carried out especially at the African level. Each organization did what it wanted according to its own ways and means.

Also, a lack of visibility of small-scale fisheries at the African and international level has been noted, during major events, etc.

Recommendations

In light of the above, we have developed a call to action on five priority areas: We believe it is time for action! Thus, we call on states to take the following actions by 2030:

1. Urgently secure preferential access and co-manage 100% of coastal areas;

2. Ensure women's participation and support their role in innovation;

3. Protect small-scale fisheries from competing sectors of the blue economy;4. Be transparent and accountable in fisheries management;

5. Build resilient communities to cope with climate change and provide opportunities for youth.
